WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in the _____, I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE Bluewater Maritime School, Inc., the Board of Trustees of Bluewater Maritime School, Inc., their officers, agents, or employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in such activity, while in, on or upon, or being transported to or from the premises where the activities are being conducted, REGARDLESS OF WHETHER SUCH LOSS IS CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise and regardless of whether such liability arises in tort, contract, strict liability, or otherwise, to the fullest extent allowed by law

REFUND POLICY

Students not accepted by the School and students who cancel their contract by notifying the school in writing within three business days before class begins are entitled to a full refund of all tuition and fees paid, less the non-refundable seat deposit, and a \$100 cancellation fee. Students who withdraw after three business days before class but before commencement of classes are entitled to a full refund of all tuition costs minus the seat reservation fee plus a \$150 cancellation fee. If student withdraws after class commencement will incur a cancellation fee of \$150, a fee for books/material, and a percentage of class tuition based on the table below. This will be based upon the date of last recorded attendance.

The official date of termination for refund purposes is the last date of recorded attendance or from the date when an approved leave of absence from the school expires whichever is later. All refunds will be made within thirty days
